In addition, any alleged violation(s) of the AUP will be handled in accordance with Section 6 of the Terms of Service.

By using the Website and Services, You have agreed in the Terms of Service to comply with this AUP. Accordingly, You represent and warrant that you will not engage in any of the following prohibited uses, activities, or conduct.

1. **Illegal Activity**. You agree not to engage in any activity that violates civil or criminal law, including any and all foreign and U.S. laws, whether federal, state or local.
